## 1985 公司大事記 Landmark Events

1985 年 1 月 19 日 中國專利代理 (香港) 有 限公司作爲國務院指定的三家涉外專利代理 機構之一寫入本日公布的中華人民共和國專 利法實施細則第14條。

1985年4月1日 中國專利法開始生效。中國 專利局—共受理了3.455件來自國内外的專利 申請, 在970件外國新申請中, 有近500件是 通過中國專利代理(香港)有限公司提交的。

1985年4月15日 公司主辦的中國最早的知 識產權中英文雙語《中國專利與商標》雜志 在香港創刊。該雜志的開辦獲得安子介、霍 英東、王光英、莊世平等知名人士的贊助。

1985年4月 公司深圳辦事處成立。

1985年5月3日-6月3日 公司總經理柳穀 書隨中國工業產權代表團赴美,向美國同行 介紹中國專利法、商標法及專利商標代理業 務。

19 January 1985 The China Patent Agent (H. K.) Ltd., as one of the three foreign-related patent agencies designated by the State Council, was mentioned in Rule 14 of the Implementing Regulations of the Patent Law of the People's Republic of China issued on the day.

1 April 1985 The Chinese Patent Law entered into force. The Chinese Patent Office received a total of 3,455 patent applications filed in and outside China. Of the 970 foreign applications, nearly 500 were filed through the China Patent Agent (H.K.) Ltd..

15 April 1985 The China Patent Agent (H.K.) Ltd. launched in Hong Kong the China Patents & Trademarks, China's earliest and only Chinese-English Quarterly on intellectual property. It had the honour of being supported by such celebrities as Ann Tse-Kai, Fok Ying Tung, Wang Guang Ying and Chuang Shih-Ping.

April 1985 The China Patent Agent (H.K.) Ltd. Shenzhen Office was set up.

1985年8月 公司北京辦事處成立。

1985年9月17日-9月28日 應日本國際貿 易促進會的激請, 柳谷書總經理與楊凱, 葉 凱東與中國專利局顧問湯宗舜赴日舉辦演講 會, 向日本企業介紹中國專利法的實施情况。

1985年10月30日-11月2日 AIPPI中國分 會在北京首次舉辦大型國際工業產權研討會。 公司的代表在會上向來自近30個國家和地區 的 300 多位與會代表作關干通過非司法程序 解决工業產權争議的演講。

1985年11月日本中國工業產權考察團訪問 公司香港總部

3 May-3 June 1985 General Manager Liu Gushu went to the United States of America as a member of the Chinese Industrial Property Delegation to speak to the US colleagues on the Chinese Patent Law. Trademark Law and the patent and trademark agency business operation.

May 1985 The China Patent Agent (H.K.) Ltd. became a member of the American Chamber of Commerce in Hong Kong.

**July 1985** The Trademark Office of the State Administration for Industry and Commerce (SAIC) pointed out in the announced letter relating to the proposed acceptance of applications for trademark registration filed by Taiwan enterprises that "businessmen from Taiwan who come back to the Mainland to apply for trademark registration will be treated in the same way as the Mainland enterprises. They can appoint CCPIT or the China Patent Agent (H.K.) Ltd. to file their applications for trademark registration".

August 1985 The China Patent Agent (H.K.) Ltd. Beijing Office came into being.

17-28 September 1985 At the invitation of the Japan Council for the Promotion of International Trade, General Manager Liu Gushu,

together with Yang Kai and Yip Hoi Tung and Tang Zongshun, consultant to the Chinese Patent Office, went to Japan on a lecturing tour, speaking to the Japanese enterprises on the enforcement of the Chinese patent law.

## 30 October-2 November 1985 The

Chinese Group of AIPPI held for the first time. International Symposium on Industrial Property in Beijing. The CPA delegate delivered a speech to more than 300 participants from nearly 30 countries and regions on the alternative procedure for the resolution of industrial property disputes.

November 1985 The Japan Industrial Property Delegation paid a visit to the CPA Headquarters in Hong Kong.
