17 February 1986 Dr Arpad Bogsch, Secretary General of WIPO, wrote to General Manager Liu Gushu, speaking highly of the excellent services the China Patent Agent (H. K.) Ltd. provided to the foreign applicants and inviting him to pay a visit to the WIPO Headquarters.

May 1986 The application filed through the China Patent Agent (H.K.) Ltd. for registration in mainland China of the trademark "Œ"À° fÃ" used on bean-dairy products was approved.
