**1993年1月1日** 修改后的中國專利法開始實施。公司就發明專利保護期限延至20年、對化學品藥品給予專利保護、增加專利授權后的撤銷程序以及冒充專利等新修改的內容,答復了客户大量的咨詢。

**1993年2月** 公司應邀在香港美國商會舉辦中國專利法修改專題報告會。

1993年4月26日-5月7日 公司組團出訪南 非。這是中國知識産權界對南非的首次訪問。

**1993年7月** 根據修訂的中國商標法及其實施細則,公司開始代理客户向中國商標局提交服務商標申請。

procedures of patent revocation and matter
relating to passing-off patents.

**February 1993** At the invitation of the American Chamber of Commerce in Hong Kong, CPA held a special lecture on the revision of the Chinese Patent Law.

**26 April-7 May 1993** A CPA delegation visited South Africa. This was the first visit to the country by the Chinese IP community.

July 1993 Under the revised Chinese
Trademark Law and its Implementing
Regulations, The China Patent Agent (H.K.) Ltd.
began to file, for its clients, applications for
registration of service marks with the Chinese
Trademark Office.

**1993年11月11日** 中國專利局局長高盧麟訪問公司香港總部。

4-5 November 1993 Entrusted by WIPO and the Chinese Patent Office, the China Patent Agent (H.K.) Ltd. held a PCT Symposium in Hong Kong, which was attended by more than 120 experts, scholars, businessmen and manufacturers from different countries and regions. This Symposium was regarded by WIPO as one of the world best ten training programs.

8-9 November 1993 The CPA executive officer delivered a speech on the revised Chinese Trademark Law at the Second Mainland-Hong Kong Intellectual Property Symposium jointly held by the China Intellectual Property Society and Hong Kong Intellectual Property Department.

**11 November 1993** Gao Lulin,
Commissioner of the Chinese Patent Office paid a visit to the CPA Headquarters in Hong Kong.
